In this context, you are requested to please comply the instructions of the Samiti Hqrs., as per the directions given in the ibid letter for filling up the online application/data of Teaching and Non-teaching staff. The Principal of each JNV are requested to check the staff in position of the Vidyalaya and ensure that data in respect of all employees are filled up in the transfer portal. For this, necessary provision has been made in the portal and the principal has to complete the task before 11th July, 2017 positively.

If the data in respect of any employee remains unfilled in the transfer portal-2017 and undue benefit is available by the said employee(s) for not participating in the transfer drive, the Principal of the concerned JNV shall be held responsible for such lapse.

Please note that since it is a time bound programme to be undertaken at Hqrs. level, in case of any delay in submission of the online application data of the staff working in the Vidyalaya, will ultimately delay the entire process and the Principal of the Vidyalaya concerned alone shall be held responsible.

Subject: Final date for extension of filling up the data in online transfer portal at the level of Principal of the JNV - regarding.

It is observed that online application data received in respect of each Vidyalaya is not matching with the number of staff in position of the Vidyalaya despite the earlier instructions for mandatory filling up of online data by each employee irrespective of their willingness for request transfer. Therefore, the Principal of each JNV is required to check the staff in position of the Vidyalaya and ensure that data in respect of all employees are filled up in the transfer portal. For this, necessary provision has been made in the portal and the Principal has to complete the task before 11th July, 2017, the deadline for completion of the task. Thereafter, the data will be freezed and the transfer process shall begin.

The Principal concerned will be held responsible, if data in respect of any employee remains unfilled in the transfer portal - 2017 and undue benefit is availed by the said employee for not participating in the transfer drive. The annual transfer drive through online process being a time bound manner, the following deadline for completion of various events are fixed as under in the review meeting chaired by Commissioner, NVS.
